NOTICE OF A COMPETITIVE FIREFIGHTER/OPERATOR EXAMINATION**

A written examination will be given in approximately ninety (90) days, on a competitive basis to approved applicants for the purpose of placing names on the competitive employment list for the class of FIREFIGHTER/OPERATOR in accordance with the provisions of the Municipal Fire and Police Civil Service Law and the rules of the St Tammany Fire District #8 Civil Service Board.

Application forms may be obtained from Susan Ohlenforst, Board Secretary, at St. Tammany Fire District #8 Station 81, located at 22455 Highway 36, Abita Springs, LA 70420 or online at stfd8.com.

Completed applications and the required attachments must be received by Susan Ohlenforst, Board Secretary, at the address listed above or mailed to P.O. Box 937, Abita Springs, LA 70420, **by Thursday, October 24, 2019 at midnight**. Approved applicants will be notified of the exact date, time, and place of the examination at least five (5) days prior to the examination date.

QUALIFICATION REQUIREMENTS

Firefighter/Operator

Unless otherwise specified, all requirements must be met before admission to examination.

*Must meet all requirements of the Municipal Fire and Police Civil Service Law, including being a citizen of the United States.

*Must be no less than 18 years of age.

*After offer of employment, but before beginning work in this class, must pass a medical examination prepared and administered by the Appointing Authority, designed to demonstrate good health and physical fitness sufficient to perform the essential duties of the position, with or without accommodation.

*Applicant must possess one of the following: high school diploma, general educational development (G.E.D. certificate), high school transcript, affidavit from the issuing high school, associate's or bachelor's degree, or college transcript, any one of which must indicate that graduation occurred, or a degree awarded. A certificate of completion shall not be sufficient to substitute for a diploma or G.E.D certificate.

*Must possess a valid motor vehicle operator's license issued by the State of Louisiana.

DOCUMENT REQUIREMENTS

*Birth Certificate, US Passport, or Certificate of Naturalization

*Copy of High School Diploma, GED Certificate, or other document proving graduation occurred.

*Copy of valid Driver's License
